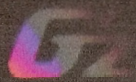

Mike calling Warren Police – business line asking for the officer’s name from the call the day before.

NOW – this dispatcher tells me she can’t find call # “12-2693” from yesterday. I then tell her Bill Ramsey called and complained about me, who was on Coy Hill Rd. She found it in the computer and it does show that the caller was Bill Ramsey. I then the officer’s name and she replied back the call doesn’t show an officer attached to it (or responded to it). I told her the officer drove up there and spoke to me. Meanwhile I hear a male voice around her, which I believe it was the chief and she asks him. He replied to her, then to me Officer Romani. She also tells me the call “reason” box is blank – states nothing on why Bill called. The male voice asks her is that Bill Ramsey on the phone. She replies no, it’s Mike Baril. The male flips out shouting and leaves the room. She then tells me for certain – the dispatch computer software has:

- No police officer is connected to call # 12-2693.
- No reason in the box explaining what the call was about.
- It doesn’t show any street address, it’s stated “up on Coy Hill”.
- It doesn’t have any follow up narrative from Dispatcher Pennsinger, saying what the “resolution” was.
- It showed the call as closed out.
- It doesn’t show Officer Romani being dispatched to Coy Hill Rd., so he only showed up via telepathic paranormal activity on his own free will. He was dispatched there via cell phone either by Chief or Pennsinger, when Ramsey called the PD’s recorded business line.
- It doesn’t have the alleged “white suspicious vehicle” registration # Officer Romani radioed in.
- It doesn’t even say anything at all – no mention of Mike Baril, CMPSA, Central MA Public Safety Assn, etc.

Today’s story is totally ass-backwards from last night’s call to your department at 18:21 hours.
