RE: Board of Selectmen candidate

Dear Mr. Lavash:

My name is Michael Baril and I physically live in the Town of Uxbridge, but I manage a non-profit organization which has been based out of Warren since 2007. Two years ago I bought a land lot off Coy Hill Rd, Warren and plan in the next year or less to finally build my house, and officially moved into Warren and continue to operate the disaster relief non-profit corporation out of your Town.

The reason I'm writing to you is I wanted to communicate some valuable details since you are the only candidate running against Robert Souza, which him & I do not get along at all. I'm not sure if you are running because you would like to overthrow him out of office, or other.?. I tried to find a phone number for you in the local phone book, but no luck.

I'm writing, pleading to you, that if you need assistance in winning against Mr. Souza, I would like to offer my services (free of charge) in holding your sign around Town, and I have been trying to share my "untold story" of what has happened from 2007 to present day of what the Town of Warren did to me, and more specifically what Mr. Souza personally screwed me over on, and I haven't even built my house or reside there yet.

This is a true factual statement that "Mr. Souza has continued to pursue a personal vendetta & "bully" me and my non-profit organization that has attempted to try & help the Town of Warren by donating money to the Town and other services to the Board of Selectmen, and to the Town as a whole." Mr. Souza has shut me off from attending B.O.S. meetings, I was banned from the police station by the Chief of Police, a public building, because [REDACTED] wrote an internal memo instructing the Chief to Police to ignore me, [REDACTED] allegedly interfered with some real estate transactions of me buying property in Town by slandering me to other residents in Town, who in turn told the neighbors of the property I was

attempting to look into/purchase to persuade the real estate agent to not sell me the house and/or land.

Furthermore, I filed 10+ requests of interest in serving on some of the Town's volunteer committees, like the Casino Study Committee, Comcast Negotiating Committee {applied 5 times over 1.5 years} and 2 others. [REDACTED] wrote denial letters to me on 2, and all the other requests he allegedly shredded my public application and when I inquired to Angela (former BOS secretary) she stated the Town never received any of them {although she signed the USPS green signature card bearing her signature}. So she was following personal "bullying" orders from [REDACTED] to get rid of me and make me go away.

I also filed a formal written complaint against a police dispatcher for allegedly posting a link to a pornographic video on the internet, that she was proven to have used the Town's police computer to post inappropriate internet comments directed at me on a public website. Mr. Souza forwarded my formal complaint to the Chief of Police and Souza told me that the dispatcher can do whatever she wants while on the Town's time, and after I reported her to the B.O.S., she & the Chief retaliated against me for blaming the Chief & her for the pornographic video, because I had done a public records request for her Town timesheets that proved she was officially working the day the porn video was posted, as well as the internet comments she slandered me on using the Town's computer to begin with!

I'll stop here, but there is more harassment that I ensued between Mr. Souza, the Chief of Police, and another town employee (on a Town Board). The last tidbit I wanted to share is that person on a Town Board & the female dispatcher tried to get me falsely arrested for driving on my own street, Coy Hill Rd, when I was driving down it looking at the radio communications tower. So my untold story is this – I would like to share this story publicly with any & all residents of Warren and yourself, who is running against Mr. Souza {prior to election day on May 7}.

Please call me as soon as you can, as I want to be sure you win this elected position in the B.O.S. which will help get rid of this alleged "Town Bully" who thinks he controls the residents of Warren (hiding the truths behind the residents' backs & out of view of the public at BOS meetings)!!!!
