  - b. Leroy E. Wilcox, or Leroy Wilcox, or Lee Wilcox





NARRATIVE FOR (D) DETECTIVE MARK J CHASE

Ref: 09-331-OF

Assigned to a plain clothes police assignment in an unmarked police vehicle working as a detective for the Warren Police Department. At approximately 1616hrs I received a phone call from Dispatcher Daniels advising of an unattended death at [REDACTED]

I responded to the scene and was met by Nancy Lowell. Nancy stated that her father in law, [REDACTED] had passed away in his first floor bedroom sometime during the day. She advised that he was last seen alive at approximately 0800hrs. I entered the room and observed an elderly white male laying on his right side in a full size bed. The white male was fully clothed and had his prescription glasses on. I check for vital signs but none were found. CPR was not initiated due to the obvious deceased condition of the body with slight rigor set in.

Per protocol I called Dispatcher Daniels and request that she notify the State Police Detectives assigned to District Attorney Early's Office and the Medical Examiner. I received a return call from a State Trooper from the Auburn CPAC office and then a call from Dr. Hull at the Medical Examiner's Office. Both declined coming to the scene as no signs of fowl play were evident and the victim had several past medical conditions that most likely contributed to his death.

Nancy advised me that Gordon had a [REDACTED] She also stated that he [REDACTED]

Photos were taken of the scene and the Gordon was removed from the home by Mark Varnum of Varnum Funeral Home in West Brookfield, Massachusetts.

On the morning of Thursday, January 9, 2014, I, Officer Gerald Millette was approached by Chief Spiewakowski and asked to assist him in an investigation of a incident that occurred yesterday involving CORRIVEAU, BRIAN and LAVASH, ROBERT. Chief Spiewakowski stated that CORRIVEAU came in at approximately 1:00 AM to report LAVASH assaulted him.

At this time I advised the CHief that I back up Sgt. LaFlower on the original call at the MOB on Monday. On Monday I was dispatched to the MOB for a disturbance call involving CORRIVEAU. On my arrival Sgt. LaFlower was speaking to CORRIVEAU by his vehicle located by the front doors. I approached and Sgt. LaFlower stated to me he was just going inside to make sure everything was all set.

At this time I started speaking with CORRIVEAU. CORRIVEAU stated that it was ridiculous that someone called the Police because of a disagreement between him and LAVASH. He then held up a home made sign that said "CORRIVEAU for Selectmen". At this time CORRIVEAU advised me he was running for Selectmen and asked how I liked his sign.

Sgt. LaFlower then returned and advised everything was ok it was only a verbal argument between LAVASH and CORRIVEAU. At no time during this interaction with CORRIVEAU did he state that any physical action took place.

At this time the Chief asked if I would go to the Town Clerks Office and speak with Nancy Lowell and Deborah LaCasse who CORRIVEAU stated witnessed this incident.

I then met with Nancy and Deborah and asked them if they could tell me what happened between LAVASH and CORRIVEAU yesterday. Both parties stated that CORRIVEAU came in with a campaign sign and placed it on top of the air conditioner. CORRIVEAU then began talking about how upset he is with the Selectmen. At this time LAVASH walked by and saw the campaign sign. Nancy stated that LAVASH asked CORRIVEAU to remove the sign from the building. CORRIVEAU then asked "WHY". LAVASH then advised him that he could not have a campaign sign in a Municipal Office Building. CORRIVEAU then asked LAVASH if he was a lawyer and LAVASH stated "No, it's state law". CORRIVEAU then told LAVASH to remove the sign himself then. LAVASH then went to take the sign down when CORRIVEAU grabbed it and told LAVASH to keep his hands off of his property.

I then asked both parties if there was any physical assault or any contact between the two. Nancy stated that she did not believe so. Nancy also stated that there was a tall pamphlet holder in between both men at the time of this incident and they could not have made contact.

Both Nancy Lowell and Deborah LaCasse agreed to write out statements in regards to this incident.

At this time I returned to the Station and relayed my findings to Chief Spiewakowski.
